HOW THE ABSENTEE SYSTEM WORKS

1. ALL BIDDING STARTS FROM THE PUBLIC IN ATTENDANCE AT THE AUCTION OR ONE HALF OF THE ABSENTEE BID.
2. BIDS ARE MADE IN COMPETITION WITH OTHER BIDDERS BIDDING, ON AN ALTERING BASIS, IN INCREMENTS SET BY THE AUCTIONEER, AS THOUGH THE BIDDER IS PRESENT AT THE AUCTION.
3. THE BIDDER UNDERSTANDS THAT THE ITEM BID ON WILL BE SOLD TO THE HIGHEST BIDDER.
4. THE ABSENTEE WILL NOT BE EXCEEDED BY ANY AMOUNT. IT IS UP TO THE ABSENTEE BIDDER TO TRUST IN THE SYSTEM AND PROVIDE A MAXIMUM BID.
5. PLEASE NOTE THAT THERE MAY BE CIRCUMSTANCES WHERE THE BID ON THE FLOOR IS ACCEPTED AT THE TOP LEVEL YOU HAVE INDICATED, OR WHERE YOUR TOP BID INDICATED DOES NOT MEET THE BID INCREMENT. IN THESE CASES YOU WILL NOT BE THE SUCCESSFUL BIDDER.
